The BKW Scheme and General meetings were chaired by Deborah Page (Chair of the Independent Board Committee). Her presentations are available - <u>Brickworks Scheme and general Meeting presentations</u>

The resolution for the combination of Brickworks and Soul Patts was approved by 97.4% of voting shareholders and with 98.8% of votes cast. The SOL Scheme was also approved so the combination will proceed to the second court hearing on 12 September 2025.

The resolution for the Grant of Performance Rights for the Managing Director and CEO was approved by 99.3% of votes cast. The SOL General Meeting also approved the Grant of Performance Right.

Responses to key questions asked at the BKW meetings:

- With the BKW share price premium to NAV the questioner was referred to the Independent Expert's satisfaction with this.
- The capital raise was to pay down debt and to increase liquidity resulting in a stronger balance sheet.

At the conclusion of the meetings Robert Millner, Chair of BKW, commented on Brickworks - that if you don't have good people, you don't have good business. And that Brickworks could not have been successful without you!

He also announced investor briefing events to be held in Sydney, Melbourne, Adelaide and Brisbane following the completion of the combination.
